West's federal practice digest 5th (kf 127 .w48 2013) has an alphabetical table of all federal cases in volumes 100 to 104c, indexed both by plaintiffs' and defendants' names (this is helpful if you only have the name of one of the parties) or older cases, you may have to use previous series. for u.s. supreme court cases, you can also use west's united states supreme court digest (kf 101.1 .u5).
